For your information and planning, the DVD Copy Control Association ("DVD CCA") Board of Directors recently voted to extend the Participating and Content Protection Advisory Council (CPAC) Membership fees reduction through 2018.

- **Participating Membership** First Functional Category - \$500.00 (USD)  
reduced from the 50% discount rate of \$2500
- **Second and subsequent categories** - \$250.00 (USD)  
reduced from the 50% discount rate of \$1250
- **CPAC Participation fee** - \$0
